SCAPA Elections

I hope everyone is having a productive 2008 so far. The news since late last year has focused on the national downturn in the economy almost as much as the race for President. Reductions in housing starts and sales, sub-prime mortgage foreclosures, increasing oil prices, the decreasing value of the dollar, federal tax rebates and the

President's economic stimulus initiatives have surpassed cable news coverage of the war in Iraq. The economic conditions, however, don't seem to be affecting South Carolina as much as other parts of the country. The *Wall Street Journal* recently reported dramatic increases in home values in North Augusta and I've read that the Columbia area is growing at a faster rate than a majority of medium-sized metropolitan areas in the US. Some South Carolina communities, however, are experiencing a modest economic slowdown. The work of managing growth continues under both scenarios. The type of work may change but the workload doesn't.

2007 was a very productive year for SCAPA:

Three excellent conferences were convened with record attendance.

All three conferences were approved for South Carolina continuing education credits.

The summer and fall conferences were ap-

proved by APA for AICP Certification Maintenance credits.

SCAPA membership increased to more than 540, the largest it's ever been.

The General Assembly did not enact anticipated regulatory takings legislation.

The Legislature did, however, amend the Local Government Comprehensive Planning Act through the adoption of the Priority Investment Act. Additional elements are now mandated for inclusion in local government comprehensive plans.

The 2008 Spring Conference, Zoning Management: Process Procedures and Tools, was held in Newberry on March 7 and was very well attended. The Newberry Firehouse, an excellent facility, had standing room only for many of the sessions. The 2008 Summer Conference is scheduled for June 27 in North Augusta. We look forward to another good turnout.

State required continuing education programs for local planning and zoning officials and staff are now well established. Most board members and commissioners have completed the six hour orientation training and are now working on the annual three hour requirement. SCAPA has been instrumental in providing continuing education and



SCAPA conferences are approved for state continuing education credit. The South Carolina Association of Counties and the South Carolina Municipal Association continue to offer periodic training. Additionally, a number of COGs are convening training sessions utilizing APA produced training CDs.

Mandatory education requirements for citizen planners and staff, while time consuming, is intended to improve local government land use decision making. The question that remains is how significant an effect it will have on the quality of planning and land development regulation in the state. When and how that might ever be measured are additional questions. In any event SCAPA will continue to be involved.

The APA National Conference will be in Las Vegas at the end of this month and sixty SCAPA members have registered. It will be interesting for those of us who haven't seen the changes Las Vegas over the last few years to observe the effects of very rapid growth.

Grant Funds Available For Public Tree Management

The South Carolina Forestry Commission, in cooperation with the U.S. Forest Service, is pleased to announce that funds have been appropriated for the 2008 Community Forestry Financial Assistance Program. This is a *reimbursable*, matching grant program to provide funding for projects that improve the management, conservation and maintenance of trees in our communities. The funding cycle for this program is July 14, 2008 through July 13, 2009.

Funding this year for the Community Forestry Grant Program will be focused on, but not limited to, the following areas:

- Performing community or county-wide forest / tree resource assessments
- Performing public tree inventories and developing assessment-based management plans
- Developing or revising local government zoning ordinances regarding trees
- Utilizing professional expertise to manage public trees
- Enhancing the technical skills of public tree managers via training & continuing education

Through this program, local units of government including counties, cities and towns, non-profit organizations and educational institutions of higher learning are eligible to apply for funding to enhance their community forest. This year, approximately \$240,000 will be awarded statewide for projects that will help communities with the management of their public tree resource. If you would prefer to receive an Application & Guidelines Packet by mail, please return the enclosed *application & guidelines packet response card* **immediately**.

The SC Forestry Commission will hold two free Grant Writing Workshops in Columbia, on April 23 and April 24, 2008. If you or someone in your organization would like to attend, please return the enclosed *grant writing workshop registration form* **immediately**.

To be considered for funding, completed grant applications must be *received* at the Forestry Commission headquarters on May 21, 2008. Therefore, we urge you to return your response card and workshop registration form as soon as possible to allow adequate time to develop a strong, well written proposal. Legislative activity that affects local government planning and the profession has been relatively minor this year. There have, however, been several bills introduced that could significantly affect local government operations. One proposal is the "Taxpayer Protection Act" that suggests a number of changes to municipal annexation procedures. A coalition led by the South Carolina Coastal Conservation League is evaluating the changes. City and county officials will surely have differing views on some of the issues and will share valid concerns. Statutory changes which may be generated by perceived annexation abuses in one part of the state may not be necessary in other parts of the state and could unintentionally impede the successful implementation of both city and county comprehensive plans.

South Carolina Education Requirements

The State of South Carolina requires appointed planning and zoning officials and professional employees to receive orientation training on an annual basis. New officials and employees must receive an initial six hours or training with a minimum of three additional hours per year thereafter.

The South Carolina Planning Enabling Education Advisory Committee was established to oversee this program. Additional information including exemption qualifications, training opportunities and programs, meeting information, and committee membership can be obtained from their website: www.scpeac.org

SC Planning Education Advisory Committee

South Carolina Code requires the formation of a State Advisory Committee on Educational Requirements for Local Government Planning or Zoning Official and Employees (SAC). These five members appointed by the Governor with the advice and consent of the Senate are charged with:

- Compiling and distributing a list of approved orientation and continuing education programs that satisfy the educational requirements in

Section 6-29-1340;

- Determining categories of persons with advanced degrees, training, or experience that are eligible for exemption from the educational requirements in Section 6-29-1340; and
- Making an annual report to the President Pro Tempore of the Senate and Speaker of the House of Representative that provides a detailed account of the advisory

committee's activities, expenses, collected fees & determinations concerning approved education programs and categories of exemption.
